

# **UCAN Chambers Advance Pro-Business Agenda** to Reopen, Rebuild CA

UCAN – the United Chamber Advocacy Network is a coalition of seven local chambers of commerce serving four counties in Northern California - El Dorado County, El Dorado Hills, Elk Grove, Folsom, Rancho Cordova, Roseville, and Yuba-Sutter.

In early March, the UCAN Chambers released their 2021 State Policy Agenda which prioritizes Reopening California's Economy and Rebuilding California's small businesses.

In April, UCAN has been working to advance this agenda by supporting legislation that unshackles business owners and operators as COVID restrictions loosen and have sponsored a bill to encourage lending to small businesses impacted by COVID-related lockdowns.

Assemblymember Kevin Kiley (R-Rocklin) invited UCAN to provide committee testimony in support of his bill, AB 54 which would prohibit the Department of Consumer Affairs, a board within the Department of Consumer Affairs, and the Department of Alcoholic Beverage Control from revoking a license for failure to comply with any COVID-19 emergency orders unless the board or department can prove that lack of compliance resulted in transmission of COVID-19.

In testimony to the Assembly **Business and Professions** Committee, UCAN Policy Advocate Dave Butler stated, "The UCAN chambers strongly support Assembly Bill 54, which seeks to remove the threat of license revocation to business owners and operators during the current COVID emergency unless spread of the

approving AB 54, the state legislature will position itself as a partner with California's small businesses, helping them avoid punitive and often arbitrary punishment during this declared emergency."

Unfortunately, AB 54 failed in committee on a party-line vote after which Kiley noted, "I'm disappointed though not surprised by the outcome, but I am glad we had the opportunity to highlight the impacts of these unilateral state decisions, which are abjectly unfair to our small business owners."

As California transitions from COVID lockdowns to reopening the economy, small businesses are looking to reopen, rebuild and regain market share. In a recent hearing before the Assembly Jobs and Economic Development Committee, James Watson, President, and CEO of the California Manufacturing and Technology Center noted that access to capital is the top priority for businesses in California, post-

In response to this need, the **UCAN Chambers approached** Assemblymember Ken Cooley (D-Rancho Cordova) to introduce AB 820 which would provide tax credits to California banks that lend to small businesses impacted by the COVID lockdowns. As Assemblymember Cooley noted, "as much as the state and federal governments have invested in relief to small businesses, there is a much greater demand for capital to rebuild. UCAN's approach to leverage the private sector is a smart, common-sense approach to address

Committee. A hearing has been delayed until clear direction is provided from the US Dept. of Treasury concerning language in the recent federal COVID relief bill that "prohibits state and local governments that receive federal aid from cutting taxes and/or fees." UCAN has joined the California Business Roundtable and other groups seeking clarity on this issue from Janet Yellen, US Secretary of the Treasury. The UCAN chambers were also

invited to provide testimony in support of another commonsense bill to benefit California's small businesses. Authored by Sen. Andreas Borgeas of Fresno, SB 430 directs state agencies to work with small businesses to help them avoid fines and penalties for minor non-compliance issues, which can often lead to tens of thousands of dollars in fees and require endless hours of staff time. In testimony to the Senate

Committee on Government Organization, Butler said, "SB 430 leverages the good work of small business advocates in state departments agencies and enables them to assist small business owners and operators in avoiding non-compliance and in some instances provide a reduction or waiver of costly fees." SB 430 received bipartisan

support in committee and was approved without dissent. The bill is now in the Senate Appropriations Committee where it is scheduled to be heard on April 19. If approved,

it will be forward to the Assembly for consideration. The UCAN Chambers have also engaged on the following bills/

**California Transportation** 

**Commission** – UCAN joined the **Orange County Business Council** and others in calling for additional workshops to allow for input from the private sector on Cal Trans' Climate Action Plan which had at that time only invited comments from environmental and social equity interests.

Keep California Working Act -UCAN supported SB 74 (Borgeas, Caballero) which would invest \$2.6 billion from the state's budget surplus toward grants to help small businesses and non-profits that sustained financial losses resulting from COVID lockdowns.

CalOSHA scope enforcement - UCAN joined the California Chamber of Commerce and others in opposing SB 606 (Gonzalez). The measure, under the guise of protecting employees during COVID, it would greatly broaden Cal/OSHA's scope of enforcement and create unnecessary anti-retaliation protections that will lead to meritless litigation against employers. SB 606 was approved 9-2 in Senate Judiciary and is now in Senate Appropriations. **Electrification** – UCAN joined

the Cal Chamber and others in opposing SB 31 (Cortese) which will impact both electric and gas rates by expanding programs to fund the decarbonization of buildings. In UCAN's annual chamber member survey, over 70% of respondents opposed mandatory electrification. SB 31 is scheduled to be heard

on April 19 in Senate Energy and Utilities.
